**OUR RULES:**

1. **SAMPLES OF PREVIOUS WORK:** We request students submit samples of artwork either drawings, paintings, or designs for review. This ensures that all of our students are committed to making great art and that they are getting the appropriate classes that support their artistic journey. These can be viewed via email or in person.
2. **REGISTRATION FEE:** All new students must pay a \$40 registration fee to cover administrative expenses.
3. **PAYMENTS:** Payment for all classes is priced in blocks of (4) four classes and is due upon last class. Payments can be made online at [www.DVAART.com](http://www.DVAART.com) or in the class with credit card, check, or cash.
4. **SPECIAL CLASSES:** Payments for special classes are individually billed and are not part of the tuition. Please refer to our website for more information. Payments can be made online at [www.DVAART.com](http://www.DVAART.com) or in the class with credit card, check, or cash.
5. **ATTENDANCE:** All students must book classes online. If a student does not show up for class that has been booked, a class will be charged.
6. **PROCEDURE:** Upon arrival, all students are expected to prepare themselves for work, i.e., prepare palette, don apron, etc. Sometimes, the Professor may request a reasonable amount of work to be performed outside of class and it is mandatory that the students comply. Upon dismissal, all students are requested to clean their workstation to ensure that it is suitable for the next student.
